

**Salem Township Board of Trustees  
Notice of Public Hearing**

**PROPOSED SPECIAL ASSESSMENT DISTRICT**

**CHUBB ROAD**

The Salem Township Board of Trustees will hold a public hearing at Salem Township Hall at 9600 Six Mile Road, Salem, MI 48168 at its regularly scheduled Board meeting at 7:00 PM on October 9, 2018, regarding its tentative intention to designate a special assessment district to assess the cost of paving and improvements to Chubb Road (between Five Mile Road and Six Mile Road) in Salem Township.

The purpose of the Public Hearing is for the Township Board to hear statements and objections to the Township Board's intent to proceed with the project and special assessment, to the project itself, including the cost estimate, and to the District proposed as the special assessment district.

Plans describing the improvement and the location of the improvement with an estimate of the cost are available for review at the office of the Salem Township Clerk. Periodic redeterminations of cost may be necessary without a change in the special assessment district and may be made without further notice.

Salem Township tentatively designates that the special assessment district, against which the costs of the improvements will be assessed, will include all the parcels with frontage along Chubb Road (between Five Mile Road and Six Mile Road) those being parcels being numbered:
